1. For periodical Renewal of Government Purchase Enlistment Certificate on expiry of every two years from the date of issue of the certificate you are required to apply for same SIX MONTH IN ADVANCE with documents like original Government Purchase Enlistment Certificate issued by NSIC, List of major Government Orders executed during the Last Two Years, Audited Statement of Accounts (Balance Sheet, Profit & Loss Accounts) for the last three years, copies of PAN Card, List of Plant & Machinery addition / deletion after the registration, copy of valid SSI Registration Certificate / Copy of Acknowledgement of Entrepreneur Memorandum Part-II filed, two declaration as per annexures "D" & "E" of the GP Application Form and copy of ownership / lease deed in respect of the factory / work premises. In case the factory / work premises are on rent. unit is required to furnish an attested copy of Rent Agreement for next two years occupation along with a copy of latest Rent Receipt.
4. Where there is change in constitutions of the unit and inspection is not involved, it will be treated as Renewal and the unit will have to pay the renewal fee along with documents for effecting change in their NSIC enlistment Certificate.
